Eisuke Sakakibara has long been closely associated with the leading questions of international finance. He was appointed professor at Keio University and Director of The Global Security Research Centre, after a 30 year career with the Ministry of Finance in Japan, most notably as Vice Minister of Finance for international affairs. He became Professor of Aoyama University in Tokyo in 2010 and prior to this he was a Professor at Waseda University from 2006. He has held many government positions including that of Director General of the International Finance Bureau and Special Advisor to the President at the Japan Center for International Finance.

Pro. Sakakibara received a Ph.D. in economics from the University of Michigan. His expertise and ability as an economist in the area of international finance was enhanced through his experience as an economist in the IMF. He has served as Associate Professor of Economics, Institute for Policy Science, at Saitama University and Visiting Associate Professor of Economics, Economics Department, at Harvard University. He is the recipient of numerous awards, including the Taylor's Award from the University of Michigan and the Bintang Mahaputra Utama from the Government of The Republic of Indonesia.
